

FAMILY-, FRIEND-, TOURIST-, BUSINESS- OR TRANSIT-VISA

Anyone is entitled to apply for a visa. The handling fee is not refundable even if visa is not granted. Applications with insufficient documentation risk being rejected without further consideration, or have an additional delay. A complete set of documentation does not mean that a visa automatically will be granted. **Note: No documents should be sent directly to the Embassy, neither by fax nor mail!** The applicant should submit the following in person (additional documentation may be required):

Please check the boxes below and sign to confirm which documents you have submitted:

- Visa application form duly completed with two passport photos not older than three months, one photo attached to the application with glue or staple, the second photo paperclipped to the application form.**
- Passport valid for three months exceeding the date of return to Thailand**
- Copy of relevant pages of the passport**
Place and date of issue, expiration date, previous visas, valid resident/work permit in Thailand etc.
- Copy of all relevant pages of Household Registration**
- Documents confirming employment, private business, school or studies; a permission for leave**
- Documents proving sustainable economic means or income of the applicant**

Alternatively, if the above can not be submitted or are insufficient, the following must be submitted:

- Original guarantee form for visits stamped by Norwegian authorities + 1 copy**
- Proof of minimum income of NOK 177.900/year of the guarantor (as of 1 May 2006)**
- Last available tax receipt*
- Three last payslips*

*This documentation must be sent by **regular or express mail directly** to the applicant, and not by fax or as a scanned attachment to e-mail. This is to avoid fraudulent documentation.*

- Confirmed booking of roundtrip air ticket, with fixed travel dates of maximum 90 days.** *Do not buy the ticket until visa has been granted. Note: If the application is approved, the visa will be issued according to the dates on the booking and the compulsory health insurance.*
- Compulsory travel medical insurance**, covering all Schengen countries, the whole period of stay and for a minimum of 30,000 Euro, should be submitted with the application. If submitted later, there will be a delay of three days for issuing the visa sticker.
- If you are under 20, you must submit:**
 - *If you are travelling alone:* *An original and a copy of letter of consent signed by both parents*
 - *If you are travelling with only one of your parents:* *An original and a copy of letter of consent from the other parent*
 - *If the parent you are travelling with has single custody:* *A shown original and a copy of certificate of single custody***Please contact the Embassy about special rules for minors under 18 years intending to visit parent living in Norway (UDI circular 2004-018 OPA).**
- Optional for applicants who want the reference or other to represent in the case: Letter of trust/proxy** *Separate form is obtainable at the Embassy*
